

Investment Policy

The fund is managed with an indexed method and is distinguished by broad diversification, low tracking errors, and low-cost management. The investment objective is to replicate the reference index as closely as possible and to minimize performance deviations from the benchmark. The Bloomberg Barclays World Government Inflation-Linked Bond Index measures the performance of investment grade, government inflation linked debt from 12 different developed market countries.
