Fund Objective

The Fund aims to provide capital growth over the long term.

Performance target: To outperform the MSCI ACWI Information Technology Index + MSCI ACWI Communication Services Index, after the deduction of charges, over any 5 year period.

Sustainability Approach

The Investment Manager uses a fundamental, bottom-up investment approach to identify companies which benefit from long-term secular themes including those which promote environmental and social characteristics. Such long-term themes include, but are not limited to, the following examples: fintech, internet 3.0, payment digitisation, internet transformation, resource optimisation process automation and electrification, and next generation infrastructure and smart cities. The Investment Manager believes these secular themes are often underappreciated and could provide attractive end markets into which well-positioned companies can grow.

Companies that the Investment Manager believes may be facing potential environmental or societal issues are subject to active engagement, the exercise of voting rights, and the proposal of action plans (where appropriate), in order to identify sustainability risks and help influence remedial change.

The Investment Manager applies screens to avoid investing in issuers involved in the following activities:

Exclusionary screens are applied to direct investments and single name derivatives (complex financial instruments) but are not applied to other derivatives or investments through collective investment schemes. If an investment becomes ineligible based on exclusionary screens it will be divested within 90 days.

The Investment Manager may invest in companies that would be excluded by the screens if the Investment Manager believes, based on its own research and as approved by its ESG Oversight Committee, that the third-party data used to apply the exclusions is insufficient or inaccurate.

Investor Stewardship

The Investment Manager has engagements (for both insights and action) with companies the Fund invests in. Engagements include a wide range of topics including strategy, capital allocation, performance, risk, management succession, board composition, corporate governance and environmental and social issues as applicable. The Investment Manager also supports several stewardship codes globally and is a signatory to the UK stewardship code.

Key Performance Indicators

Whether the Fund has invested in line with its sustainability approach will be measured with reference to:

- Carbon intensity of the Fund compared with its benchmark
 - Measured as Scope 1 + Scope 2 greenhouse gas emissions normalized by sales, which allows for comparison between companies of different sizes. Scope 1 emissions are those from sources owned or controlled by the company, typically direct combustion of fuel as in a furnace or vehicle. Scope 2 emissions are those caused by the generation of electricity purchased by the company.
- Carbon footprint of the Fund compared with its benchmark
 - ▶ Measured as Scope 1 + Scope 2 greenhouse gas emissions (if available)
- UNGC Principles and OECD MNE status of the Fund
 - ▶ UNGC compliance covers matters including human rights, labour, corruption, and environmental pollution.
- Engagement
 - Number of companies engaged with in line with the Investment Manager's engagement approach.
- ESG exclusion status
 - The exclusion of controversial activities deemed by the investment manager as having the potential to cause material negative environmental or social outcomes.
