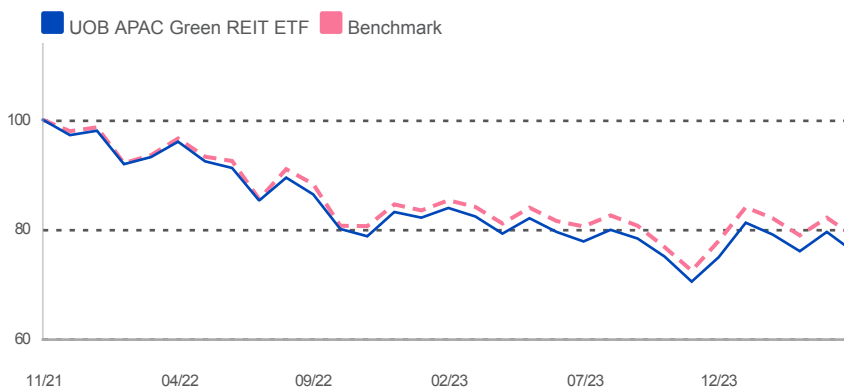


# UOB APAC Green REIT ETF

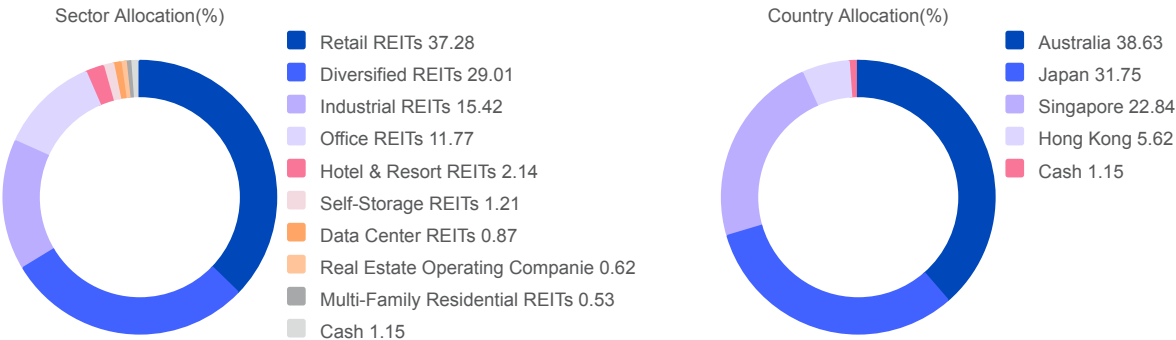
