- Eastspring Investments - Asian Bond Fund is referred to as the 'Fund'.
- The Fund invests in bonds and is subject to interest rate fluctuation and exposed to credit default, valuation and credit rating risks as well as credit risk of the counterparties with which it trades. Pertaining to investments in high yield/unrated/non-investment grade bonds, these securities may be subject to higher credit risks and liquidity risks, compared with investment grade bonds, with an increased risk of loss of investments.
