Objectives

WisdomTree FTSE 100 1x Daily Short is a fully collateralised, UCITS eligible Exchange Traded Product (ETP) designed to provide investors with a short exposure to the FTSE 100. The ETP tracks the FTSE 100 Daily Short Strategy RT Gross TR Index (UKXI1X), providing a total return comprised of -1 times the daily performance of the FTSE 100 Declared Dividend Total Return Index, adjusted to reflect fees as well as the costs and revenues inherent to shorting stocks. For example, if the FTSE 100 Declared Dividend Total Return Index, adjusted to reflect fees as well as the costs and revenues inherent to shorting stocks. For example, if the FTSE 100 Declared Dividend Total Return Index rises by 1% over a day, then the ETP will fall by 1%, excluding fees.
