#### Objectives and investment policy

The fund is passively managed. INVESTMENT OBJECTIVE: The aim is for your investment to track the performance, before fees and expenses, of the MSCI EM Low Carbon SRI Leaders Index (index). DESCRIPTION OF INDEX: The index is based on the MSCI Emerging Markets Index (Parent Index), which is designed to reflect the performance of certain shares in large and medium-sized listed companies in global emerging markets. In order to be eligible for inclusion in the index, companies must be eligible for inclusion in the Parent Index and must display high environmental, social and governance (ESG) performance and low current and potential carbon exposure, relative to their sector peers. ESG CRITERIA: The constituent selection process is based on three sets of rules applied sequentially, as disclosed in the prospectus and/or supplement: (i) Low Carbon Transition Risk Assessment Rules, (ii) High ESG Performance Selection Rules and (iii) Low Carbon Emissions Rules. The remaining securities are then weighted by their free-float adjusted market capitalisation and are also subject to a relative weight cap against their weight in the Parent Index. INDEX REBALANCING, CALCULATION AND ADMINISTRATION: The index is calculated on a total return net basis which means that all dividends and distributions by the companies are reinvested in


