Objectives

WisdomTree EURO STOXX Banks 3x Daily Leveraged is a fully collateralised, UCITS eligible Exchange Traded Product (ETP) designed to provide investors with a leveraged exposure to the EURO STOXX Banks. The ETP tracks the EURO STOXX Banks Daily Leverage 3 EUR Net Return Index (SX7T3L), providing a total return comprised of 3 times the daily performance of the EURO STOXX[®] Banks Net Return Index, adjusted to reflect fees and costs inherent to maintaining a leveraged position in stocks. For example, if the EURO STOXX[®] Banks Net Return Index rises by 1% over a day, then the ETP will rise by 3%, excluding fees. However if the EURO STOXX[®] Banks Net Return Index falls by 1% over a day, then the ETP will rise by 3%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

For periods of longer than one day, the return of the product is not the same as the return of the Index multiplied by a factor of 3 (the "Leverage Factor"). Term

The risk indicator assumes you keep the product for 1 day. The actual risk can be significantly higher if you cash in at an early or later stage and you may get back less.

We have classified this product as 7 out of 7, which is the highest risk class.
