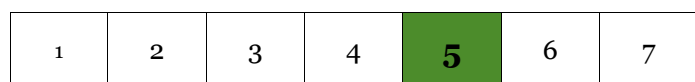
## What is this product?

Type: Debt security

Objectives: ETFS Physical Platinum is designed to enable investors to gain a simple and cost-efficient way to access the platinum market by providing a return equivalent to the movements in the platinum spot price less the applicable management fee. The product reflects the performance of the underlying spot price such that, for example, if the spot price were to rise in value by 5% over a period, the product would increase in value by 5% over that same period (before fees, expenses and adjustments) and if the spot price were to fall in value by 5% over a period, the product would fall in value by 5% over that same period (before fees, expenses and adjustments). The product is an exchange traded product ("ETP"). Securities in this ETP are structured as debt securities and not as shares (equity). They are traded on exchange just like shares in a company. This ETP is backed by physical allocated Platinum held by an independent custodian, HSBC Bank plc. Only metal that conforms with the London Platinum and Palladium Association's (LPPM) rules for Good Delivery for Platinum and Palladium can be accepted by the custodian. Each physical bar is segregated, individually identified and allocated.

Intended retail investor: This product is intended for basic retail investors who can bear loss of capital, who are not seeking to preserve capital and who are not looking for capital guarantee.
