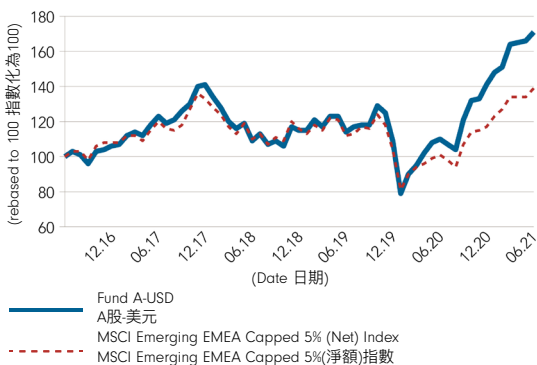

Summary of Investment Objective 投資目標摘要

The fund is an Equity fund and aims to provide long-term capital growth through investing primarily (i.e. at least 70% of the fund's assets) in securities of companies having their head office or main activities in the less developed countries of Central, Eastern and Southern Europe (including Russia), the Middle East and Africa including those that are considered as emerging markets according to the MSCI EM Europe, Middle East and Africa Index. (Please refer to the offering document for Investment Objective of the fund)

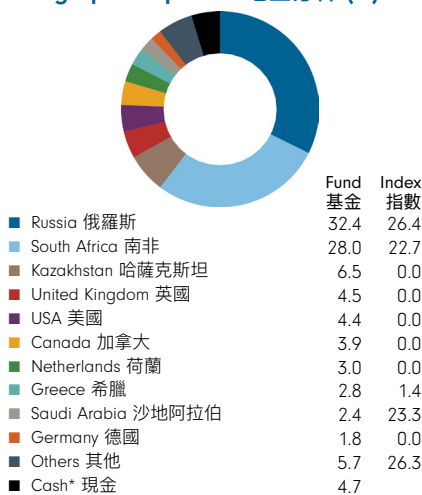

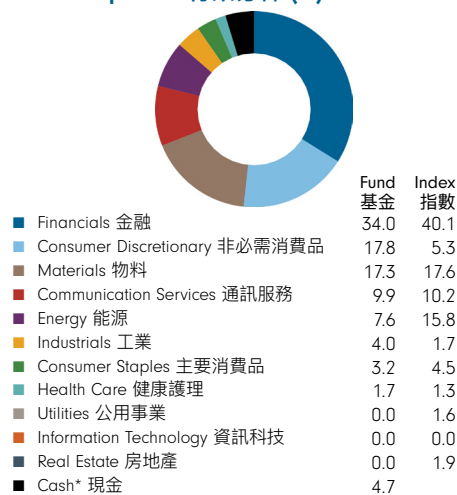
