What is this product?

Type

Jersey law governed, uncertificated, registered, collateralised debt security.

Objectives

WisdomTree Copper is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to Copper futures contracts. The ETC aims to replicate the Bloomberg Copper Sub Total Return Index (BCOMHGTR) by tracking the Bloomberg Copper Sub Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Copper Sub Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg Copper Sub Total Return Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

Intended Retail Investor

Term

This product does not have a fixed term. The term will depend on how long you choose to hold the product. The Issuer is entitled to terminate this product unilaterally.

The risk indicator assumes you keep the product for 1 year. **The actual risk can be significantly higher if you cash in at an early or later stage and you may get back less.**

We have classified this product as 5 out of 7, which is a medium-high risk class.

The unfavourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Copper between 04/12/2014 and 23/11/2015. The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree Copper between 07/11/2018 and 25/10/2019. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Copper between 22/05/2020 and 11/05/2021. Where period of time between the dates is less than the recommended holding period the performance has been extrapolated by linear transformation to the recommended holding period.

What happens if WisdomTree Commodity Securities Limited is unable to pay out?
