### **Objectives**

WisdomTree Silver 3x Daily Short is a fully collateralised Exchange Traded Commodity (ETC) designed to provide investors with a leveraged short exposure to Silver . The ETC provides a total return comprised of -3 times the daily performance of the Solactive Silver Commodity Futures SL Index (SOLWSSI1), plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Solactive Silver Commodity Futures SL Index rises by 1% over a day, then the ETC will fall by 3%, excluding fees. However if the Solactive Silver Commodity Futures SL Index falls by 1% over a day, then the ETC will rise by 3%, excluding fees.

You may trade this product on various stock exchanges at your own discretion.
