## What is this product?

### **Type**

Jersey law governed, uncertificated, registered, collateralised debt security.

#### **Objectives**

WisdomTree Tin is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to Tin futures contracts. The ETC aims to replicate the Bloomberg Tin Sub Total Return Index (BCOMSNTR) by tracking the Bloomberg Tin Sub Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Tin Sub Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg Tin Sub Total Return Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result
