REPORT OF THE MANAGER TO THE UNITHOLDERS

Introduction

The ChinaAMC MSCI China A Inclusion Index ETF (the "Sub-Fund"), a sub-fund of ChinaAMC ETF Series, an umbrella unit trust established under Hong Kong law by a trust deed dated 28 May 2012 between China Asset Management (Hong Kong) Limited (the "Manager") and Cititrust Limited (the "Trustee"). Units of the Sub-Fund (the "Units") are listed on The Stock Exchange of Hong Kong Limited (the "SEHK") and traded on the SEHK like listed stocks. The Sub-Fund's RMB counter (stock code: 83197) and HKD counter (stock code: 03197) commenced trading on the SEHK on 7 February 2018. The Sub-Fund is a passively-managed index tracking exchange traded fund ("ETF") falling under Chapter 8.6 of the Code on Unit Trusts and Mutual Funds. The Sub-Fund is a physical ETF that seeks to track the performance of the MSCI China A Inclusion Index (the "Index"). It invests directly in China A-shares through the Shanghai Hong Kong Stock Connect and Shenzhen - Hong Kong Stock Connect (the "Stock Connect") and may also invest through the Renminbi Qualified Foreign Institutional Investor ("RQFII") program on an ancillary basis.

The Manager may also use a representative sampling strategy where it is not possible to acquire certain A-Shares which are constituents of the Index due to restrictions or limited availability. This means that the Sub-Fund will invest directly in a representative sample of securities that collectively has an investment profile that aims to reflect the profile of the Index. The securities constituting the representative sample may or may not themselves be constituents of the Index.

Performance of the Sub-Fund

The investment objective is to provide investment results that, before fees and expenses, closely correspond to the performance of the Index.

There were 2 rebalances for the Index from 1 January 2021 to 30 June 2021. As of 30 June 2021, the Sub-Fund comprised of all 479 constituent stocks in the Index.
