- This fund invests primarily in special situations stocks and smaller growth companies in Asia (excluding Japan).
- The fund is subject to equities risk, risk to capital and income, foreign currency risk and risks of investing in emerging markets.
- The fund may invest in medium and small companies. Equities of small and mid capitalisation companies can be more volatile to adverse economic developments and less liquid than those of larger companies.
- The use of ESG criteria may affect the fund's investment performance and may result in a return unfavorably to similar products without such focus. The ESG characteristics of securities may change over time, which may require the Investment Manager disposing of such securities when it might be disadvantageous to do so, which may lead to a fall in the fund's value. Investment Objective 投資目標

The fund aims to achieve capital growth long term. The fund invests at least 70% (and normally 75%) of its assets, in equities of companies that are listed, headquartered or do most of their business in Asia (excluding Japan) including emerging markets. The fund will have a mixture of investments in larger, medium and smaller sized companies. The fund will seek opportunities in special situations equities which are shares in companies that generally have attractive valuations in relation to net assets or earning potential and/or companies which are undervalued and whose recovery potential is not recognised by the market. The fund may also invest in money market instruments on an ancillary basis. The fund may invest in the following assets according to the percentages indicated: China A and B shares (directly and/or indirectly): less than 30% (in aggregate); SPACs: less than 5%.

基金旨在實現長線資本增長。基金將最少70%（通常為75%）的資產投資於在亞洲（日本除外）（包括新興市場）上市、設立總部或進行大部份業務之公司的股票。基金的投資組合將涉及一系列大、中及小型公司。基金將在特別機會股票中尋找機會，即就淨資產或盈利潛力而言通常估值具有吸引力的公司股票及/或被低估且其復甦潛力未被市場認可的公司股票。基金亦可在輔助基礎上投資於貨幣市場工具。基金可按所示百分比投資於以下資產：中國A股和B股（直接及/或間接）：少於30%（總計）；SPACs：少於5%。

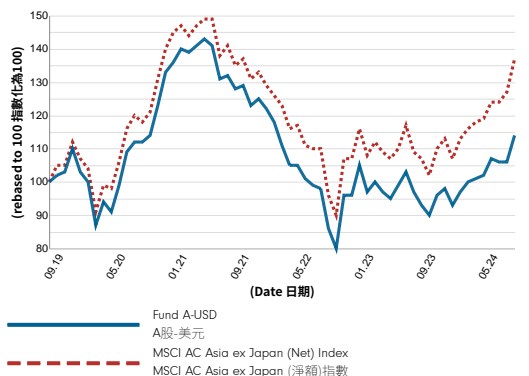

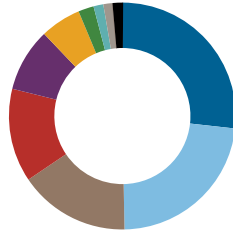

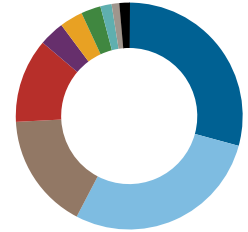
