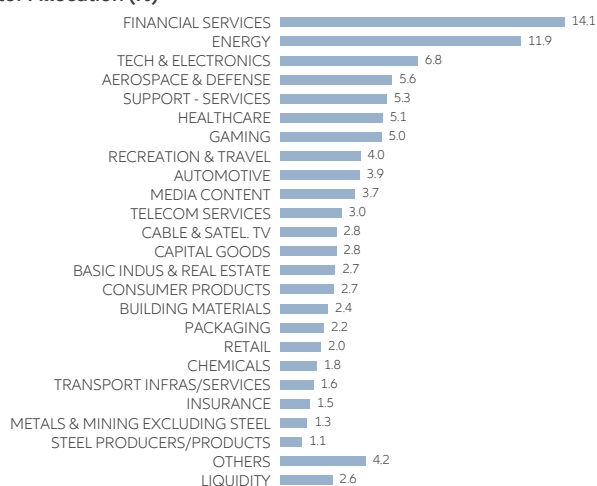
Indexed Performance since Inception (NAV-NAV)
