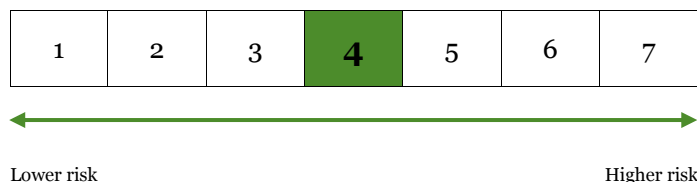

What is this product?

Type:	Debt security
Objectives:	ETFS Precious Metals is designed to enable investors to gain an exposure to a total return investment in a basket of commodity futures by tracking the Bloomberg Precious Metals Subindex (the "Index") and providing a collateral yield. The product reflects the performance of the Index such that, for example, if the Index were to rise in value by 5% over a period, the product would increase in value by 5% over that same period (before fees, expenses and adjustments) and if the Index were to fall in value by 5% over a period, the product would fall in value by 5% over that same period (before fees, expenses and adjustments). The product is an exchange traded product ("ETP"). Securities in this ETP are structured as debt securities and not as shares (equity). They are traded on exchange just like shares in a company. The ETP is backed by swaps with Citigroup Global Markets Limited and Merrill Lynch International. The payment obligations of the swap counterparties to the Issuer are protected by collateral held in a segregated account at an independent custodian, The Bank of New York Mellon.
Intended retail investor:	This product is intended for basic retail investors who can bear loss of capital, who are not seeking to preserve capital and who are not looking for capital guarantee.

What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 3 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

What happens if ETFS Commodity Securities Limited is unable to pay out?

What are the costs?

Costs over Time
