Objectives and Investment Policy

Investment Objective:

The Fund aims to track as closely as possible the returns of the FTSE EPRA Nareit IdealRatings Developed Islamic Index (the Index).

Investment Policy:

The Index is a subset of the FTSE EPRA Nareit Developed Index (Parent Index), includes REITs and Real Estate Holding and Developing companies in developed markets, that comply with Shariah investment principles, as defined by the Index Provider.

The Fund will aim to replicate the net total return performance of the Index.

The Index is constructed by applying Business Activities and Financial Screening according to the FTSE IdealRatings Islamic Indexes Screening Guide to the Parent Index. By applying Business Activities Screening, investment will not be permitted in companies deriving more than 5% of their total revenue, or in REITs generating income, through tenants operating in specific business activities, such as, companies with exposure to: defense or weapons, adult entertainment, alcohol, gambling, tobacco, pork-related products, music, conventional finance services.

By applying Financial Screening and Shariah investment principles, investment will not be permitted in: companies with conventional debt divided by average daily market capitalisation for the prior 24 months exceeding 33%; companies where the sum of cash and short-term interest-bearing securities divided by average daily market capitalisation for the prior 24 months exceeds 33%; fixed income preferred shares or trust units. The Fund is passively managed and aims to invest in the shares of the companies in generally the same proportion as in the Index. There may be circumstances when it is

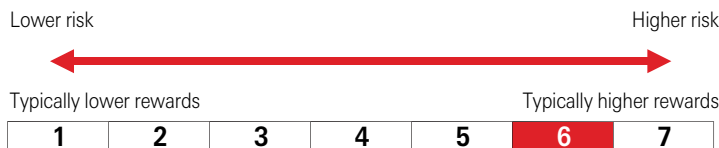
not possible for the Fund to invest in all constituents of the Index and may gain exposure by using other Shariah compliant investments such as depositary receipts. The Shariah committee monitors the Fund periodically and issues an annual Shariah certificate on the Fund's compliance with Shariah principles. This certificate is included in the annual report of the Fund as a confirmation of the Shariah compliance for that year. Before investing, please do check that this Fund meets your Shariah requirements, and if in any doubt please consult an adviser.

The Fund may invest up to 35% of its assets in securities from a single issuer during exceptional market conditions.

The Fund may only use Shariah-compliant foreign exchange contracts (including spot and forward contracts) for hedging purposes.

- ◆ The reference currency of the Fund is USD. The reference currency of this share class is USD.
- ◆ The reference benchmark has a high level of concentration. This means that a small number of securities make up a significant proportion of the benchmark.
- ◆ Income is reinvested.
- ◆ Authorised Participants only may deal in the Fund's shares directly with the UCITS.
- ◆ The Fund's shares are listed on one or more stock exchange(s).
- ◆ You may sell your investment on most working days.
- ◆ Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

Why is this Fund in this specific category?

This Fund is classified in category 6 because its price or simulated data has shown high fluctuations historically.

Material risks not fully captured by the Risk and Reward Indicator:

- ◆ **Counterparty Risk** The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.
- ◆ **Derivatives Risk** Derivatives can behave unexpectedly. The pricing and volatility of many derivatives may diverge from strictly reflecting the pricing or volatility of their underlying reference(s), instrument or asset.

- ◆ **Exchange Rate Risk** Changes in currency exchange rates could reduce or increase investment gains or investment losses, in some cases significantly.
- ◆ **Index Tracking Risk** To the extent that the Fund seeks to replicate index performance by holding individual securities, there is no guarantee that its composition or performance will exactly match that of the target index at any given time ("tracking error").
- ◆ **Investment Fund Risk** Investing in other funds involves certain risks an investor would not face if investing in markets directly. Governance of underlying assets can be the responsibility of third-party managers.
- ◆ **Investment Leverage Risk** Investment Leverage occurs when the economic exposure is greater than the amount invested, such as when derivatives are used. A Fund that employs leverage may experience greater gains and/or losses due to the amplification effect from a movement in the price of the reference source.
- ◆ **Liquidity Risk** Liquidity Risk is the risk that a Fund may encounter difficulties meeting its obligations in respect of financial liabilities that are settled by delivering cash or other financial assets, thereby compromising existing or remaining investors.
- ◆ **Operational Risk** Operational risks may subject the Fund to errors affecting transactions, valuation, accounting, and financial reporting, among other things.
- ◆ **Real Estate Investments Risk** Real estate and related investments can be negatively impacted by any factor that makes an area or individual property less valuable.
