Objectives

WisdomTree Long EUR Short USD is a fully collateralised, UCITS eligible Exchange Traded Product (ETP) designed to provide investors with an exposure to EUR relative to USD. The ETP tracks the MSFXSM Long Euro Total Return Index (MSCEEURL), providing a total return comprised of the daily performance of FX forward contracts being Long EUR relative to USD, plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if EUR rises by 1% relative to USD over a day, then the ETP will rise by 1%, excluding fees. However if EUR falls by 1% relative to USD over a day, then the ETP will fall by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the forward contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product.
