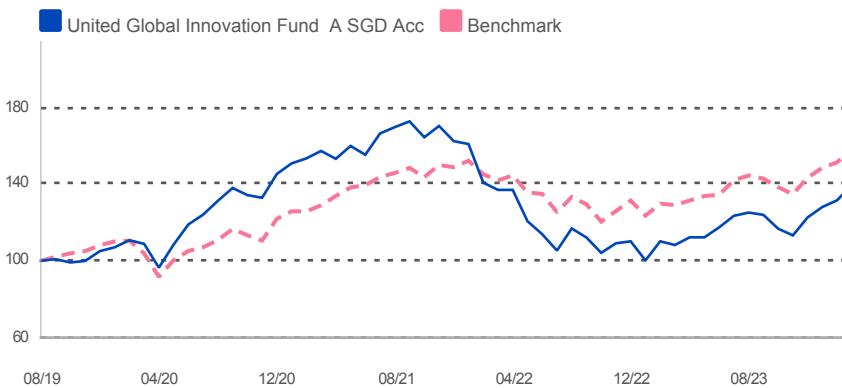


# United Global Innovation Fund

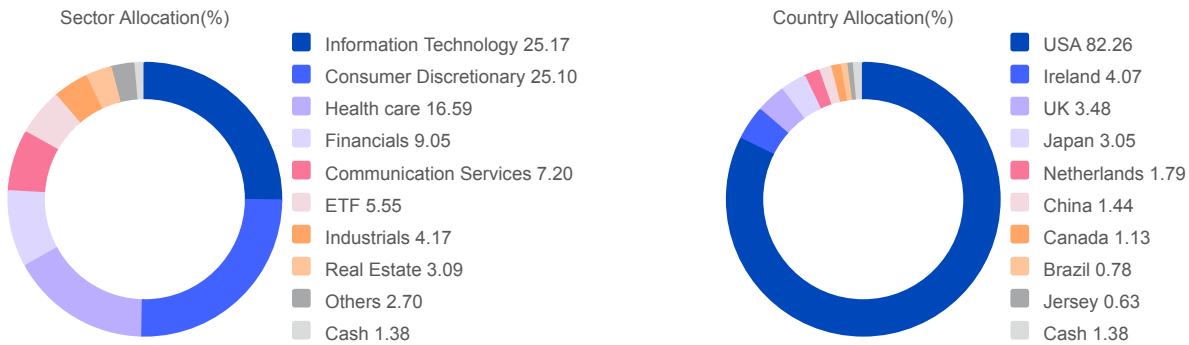
