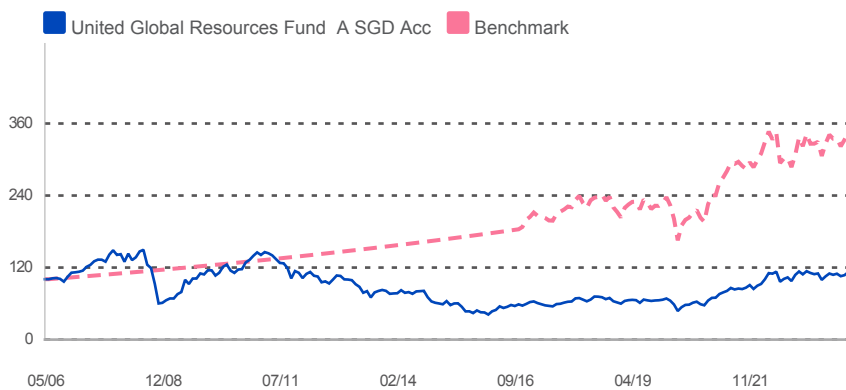


United Global Resources Fund

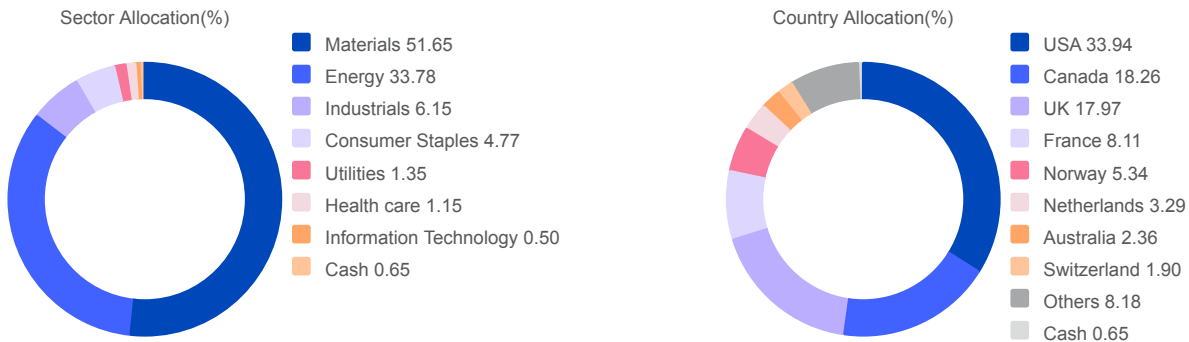
