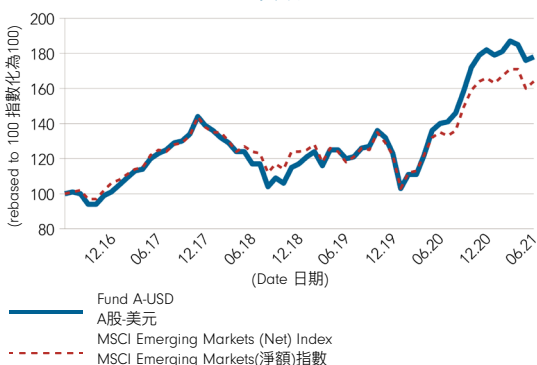
- This fund invests primarily in equity securities in Latin America, South East Asia, Africa, Eastern Europe (including Russia) and the Middle East.

The fund is an Equity fund and aims to provide long-term capital growth. The fund invests principally (i.e. at least 70% (and normally 75%) of the fund's assets) in equity securities of areas experiencing rapid economic growth including countries in Latin America, South East Asia, Africa, Eastern Europe (including Russia) and the Middle East. 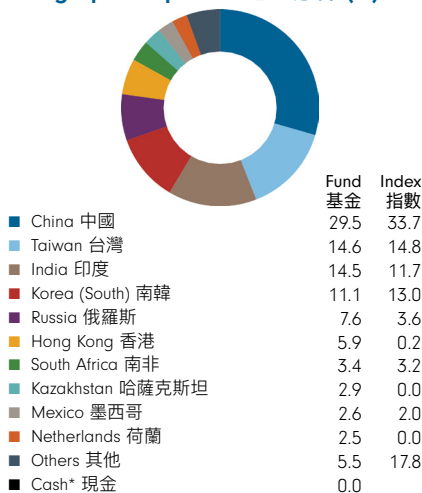

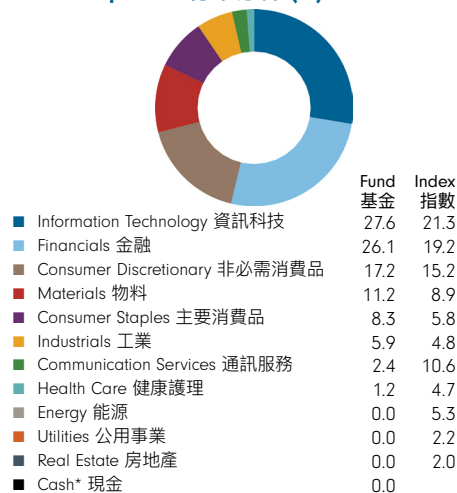
