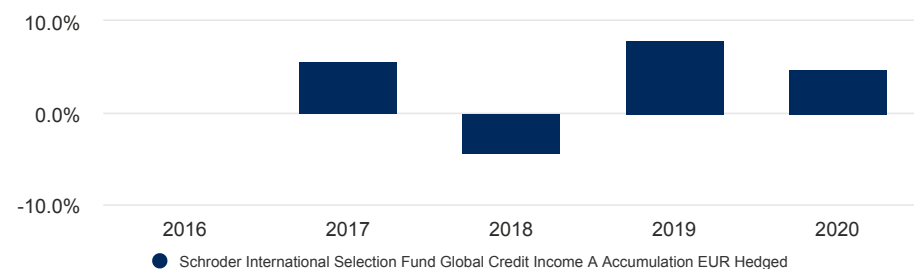

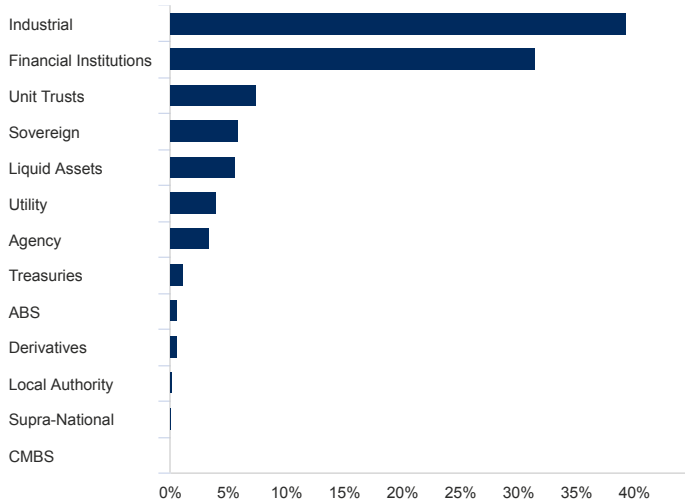

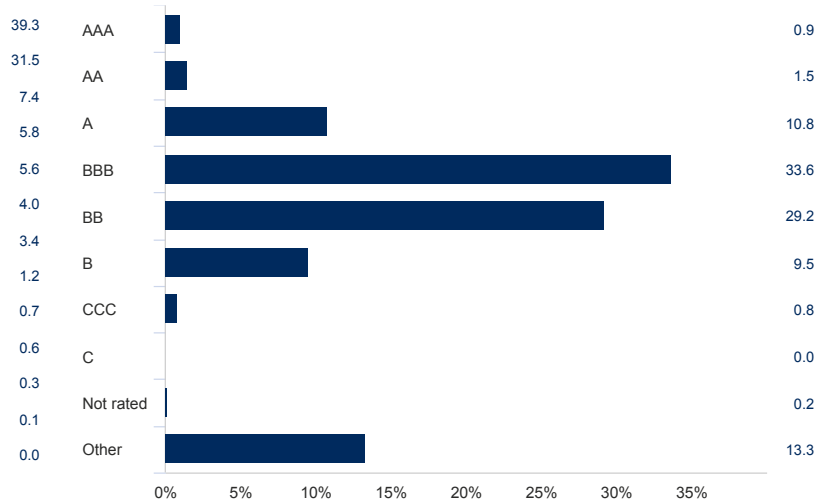

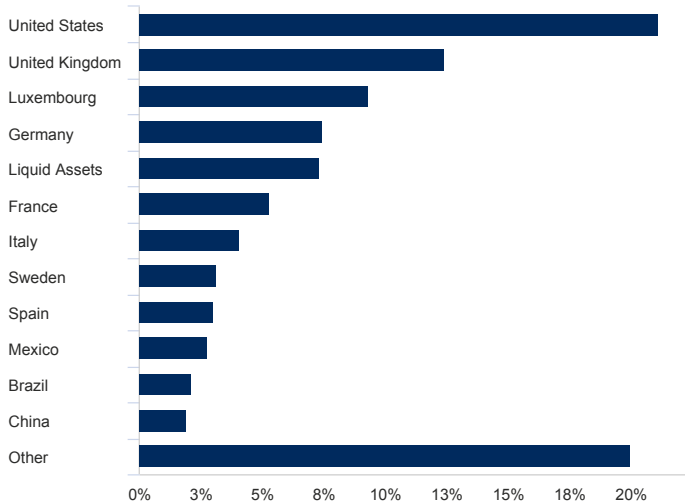
### Sector (%)
