What is this product?

Type: Debt security

Objectives: ETFs Long USD Short EUR is designed to enable investors to gain exposure to US Dollars ("USD") relative to Euro ("EUR") by tracking the MSFX Long US Dollar/Euro Index (TR) (the "Index"), which aims to reflect the performance of a position in forward contracts which are rolled on a daily basis. The product provides a long exposure to USD relative to EUR. For example, if USD were to rise in value relative to EUR, the Index (tracked by the ETC) would rise in value. Conversely if USD were to decrease in value relative to EUR, the Index would also decrease in value. The Index return also includes a component based on the interest rate differentials, reflecting the difference between the USD and the EUR exchange rates. The Index is a total return Index, which means that it also provides a collateral yield. The product is an exchange traded product ("ETP"). Securities in this ETP are structured as debt securities and not as shares (equity). They are traded on exchange just like shares in a company. The ETP is backed by swaps with Morgan Stanley & Co. International plc. The payment obligations of the Issuer are protected by collateral held in a segregated account at an independent custodian, The Bank of New York Mellon.

Intended retail investor: This product is intended for basic retail investors who can bear loss of capital, who are not seeking to preserve capital and who are not looking for capital guarantee.
