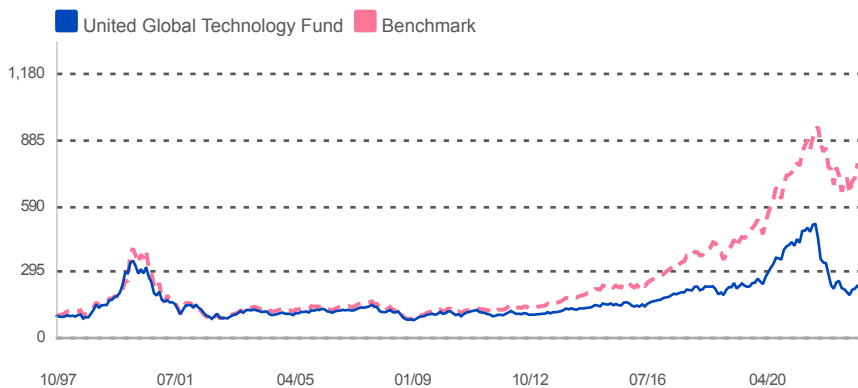


# United Global Technology Fund

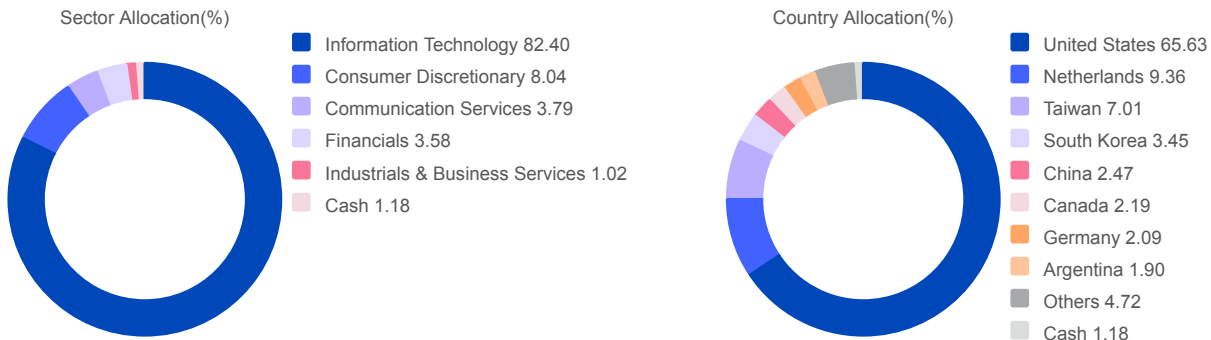
