Objectives and investment policy

Objective

The fund aims to provide above average income and capital growth in the medium term.

Investment Policy

The fund invests in the shares of UK and overseas companies and cash.

Essential features of the Fund

- The fund has the discretion to invest in the investments as described above with no need to adhere to a particular benchmark.
- The fund has no specific target market or geographic sector.
- The fund aims to distribute available income every six months.
- You can buy and sell shares in the fund on each working day.
- The fund aims to distribute available income every six months.
- Derivatives may be used to manage the risk profile of the fund, reduce costs or generate additional capital or income. Currency hedging arrangements may be used to reduce the risk of currency movements in the value of overseas investments held by the fund.
- Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Risk and reward profile



- This indicator shows how much a fund has risen and fallen in the past, and therefore how much a fund's returns have varied. It is a measure of a fund's volatility. The higher a fund's past volatility the higher the number on the scale and the greater the risk that investors in that fund may have made losses as well as gains. The lowest number on the scale does not mean that a fund is risk free.

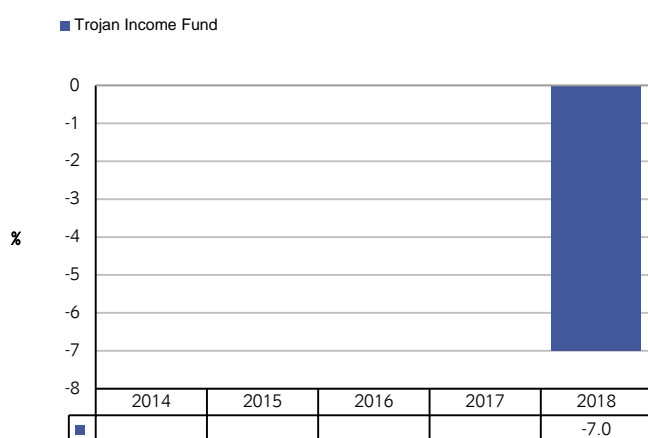
The entry charge shown is a maximum figure. In some cases investors may pay less. You can find out the actual charges from your financial advisor or distributor.
