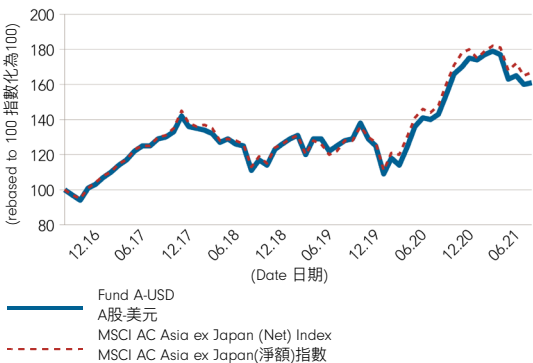
- This fund invests primarily in special situations stocks and smaller growth companies in Asia (excluding Japan).

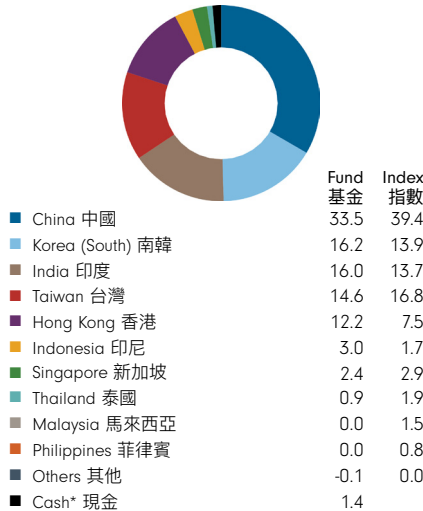

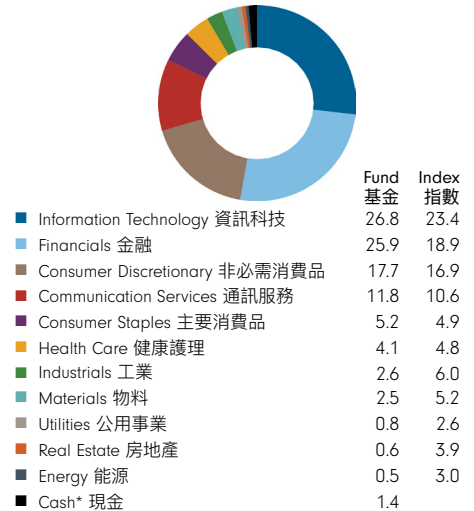
Geographic Exposure 地區分佈 (%)
