## JUNE 2022 / FACTSHEET

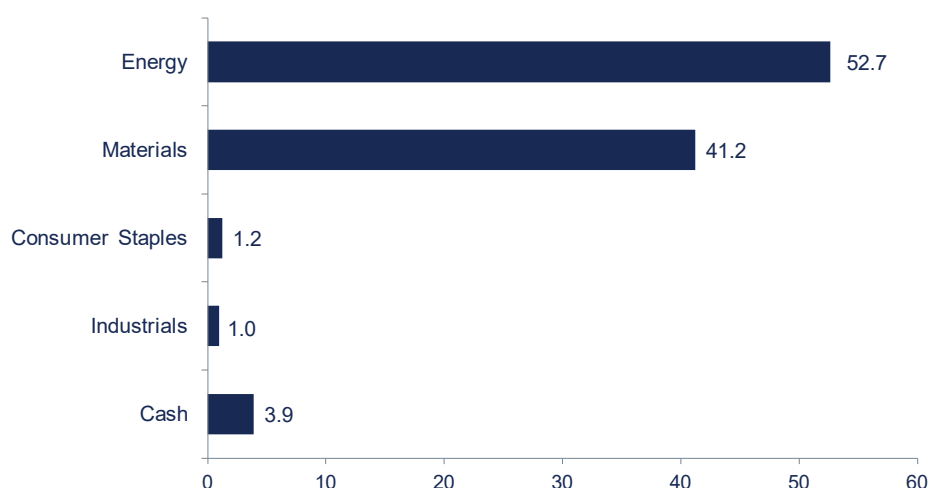

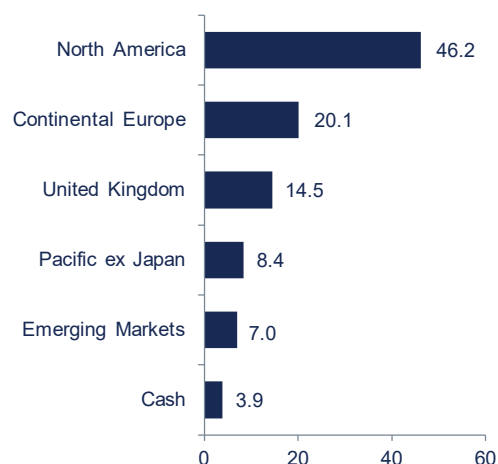
## TOP SECTOR WEIGHTING (% OF NAV)<sup>3</sup>

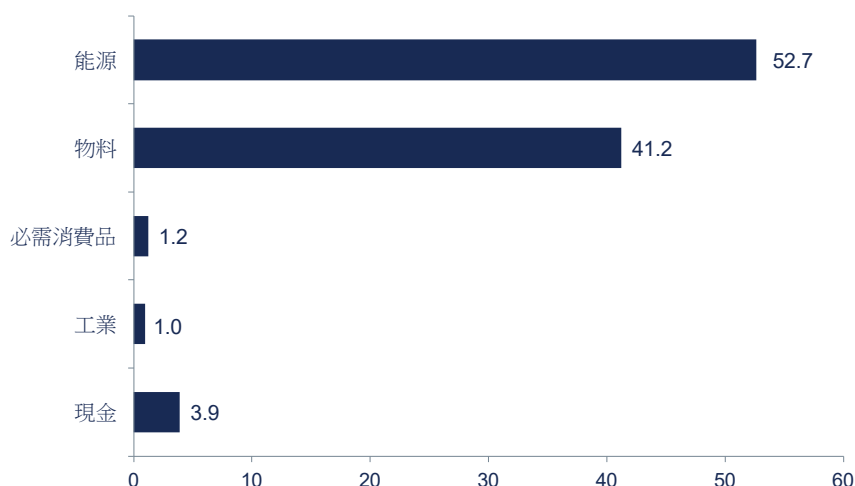

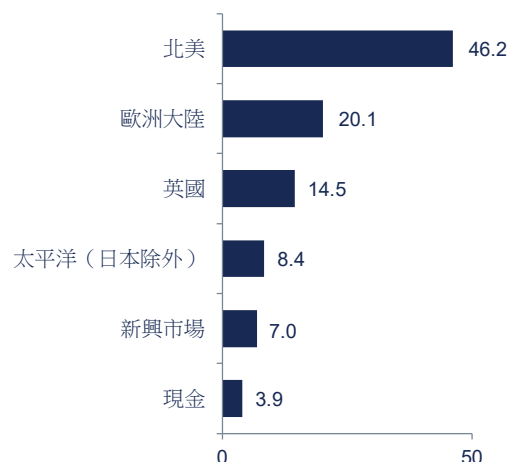
主要行業比重 (佔資產淨值%)<sup>3</sup>
