Objectives and Investment Policy

Investment objective: The investment objective of Thematics AI and Robotics Fund (the "Fund") is long-term growth of capital.

Investment policy:
The Fund invests primarily in equity securities of companies around the world that have been identified by the Investment Manager as being participants in or having an exposure to potential growth relating to the investment theme of global artificial intelligence ("Al") and robotics. The Fund invests at least two-thirds of its total assets in equity securities worldwide. The Fund's equity investments may include common stocks, preferred stocks and, on an ancillary basis, closed-ended real estate investment trusts ("REITS"), equity-related instruments such as warrants, equity-linked notes and convertible bonds whose value is derived from the value of any of those equity securities, and depositary receipts for any of any of those equity securities, and depositary receipts for any of those equity investments.

As part of the Fund's investments in equity securities worldwide, the Fund may also invest up to 30% of its total assets in emerging markets companies including, but not limited to, certain eligible A-Shares via the Shanghai-Hong Kong Stock Connect program and/or Shenzhen-Hong Kong Stock Connect program (collectively, the "Stock Connects").

The Fund may invest up to one-third of its total assets in money market instruments cash and cash equivalents.

The Fund may invest up to 10% of its net assets in undertakings for collective investment, including but not limited to, exchange traded funds that qualify as UCITS.
The Fund is actively managed with an emphasis on companies developing their services and technologies in relation to the global AI and robotics theme and having, in the opinion of the lovestment Manager, an attractive risk/return profile driven by Investment Manager, an attractive risk/return profile driven by long-term secular trends.
As part of the investment strategy of the Fund, the Investment

Manager includes Environmental, Social and Governance (ESG) considerations for both the selection and the capital allocation decision processes which will result in:

• excluding controversal activities and issuers during

the screening process; including non-financial considerations such as ESG risks materiality assessment in the fundamental

analysis of companies; holding active ownership by voting in general meetings and engaging with companies held in the portfolio on ESG topics.

The Fund is unconstrained by industry, currency, index, geographical considerations or capitalization size and the Investment Manager aims to invest in companies whose shares are selling below the Investment Manager's estimate of intrinsic value.

The Reference Currency of the Fund is the US Dollar.

Shareholders may redeem Shares on demand on any business day in Luxembourg. Stock Connect Risk: The Fund may invest in China "A" shares via the Shanghai-Hong Kong Stock Connect and/or Shenzhen-Hong Kong Stock Connect programs which are subject to additional clearing and settlement constraints, potential regulatory changes as well as operational and


