Objectives and investment policy

- The Fund seeks a level of income above the FTSE All Share Index together with some capital growth by investing, directly or indirectly, primarily in equities and equity linked securities (securities whose returns are determined by the performance of the underlying equities) of UK companies or of companies which derive a substantial part of their revenues from the UK. It may also invest in money market securities (securities used by government and companies and others who wish to borrow money for short periods, usually less than a year), fixed and floating rate government and corporate bonds, bonds convertible into common stock, preferred shares (shares that entitle the holder to a fixed-rate dividend, paid before any dividend is distributed to holders of ordinary shares) and other fixed income investments. The investment exposure created by these securities may be altered through the use of currency transactions.
- Fixed income investments may be issued by any government, company or international agency.
- The Fund may use financial derivative instruments (instruments whose prices or are dependent on one or more underlying asset 'FDI') extensively for investment purposes as well as for hedging (the practice of undertaking one investment activity with the aim of protecting against loss in another) or other efficient portfolio management purposes (technique consisting in maximising returns while minimising risk).

 Income earned on investments will be distributed to investors as an income payment. Shares can be bought and sold on each Dealing Day.
