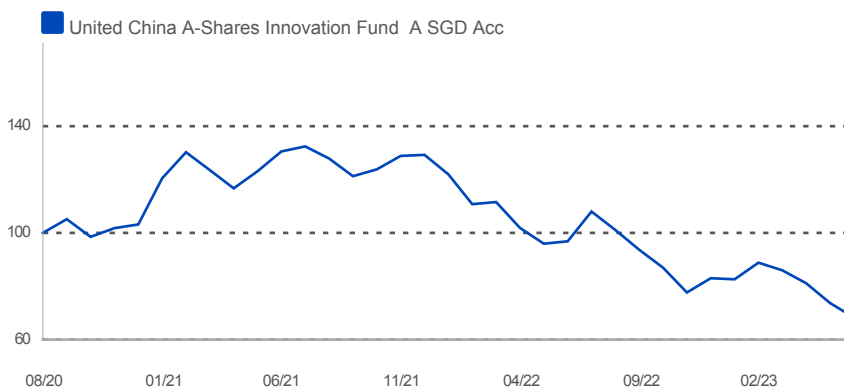


United China A-Shares Innovation Fund

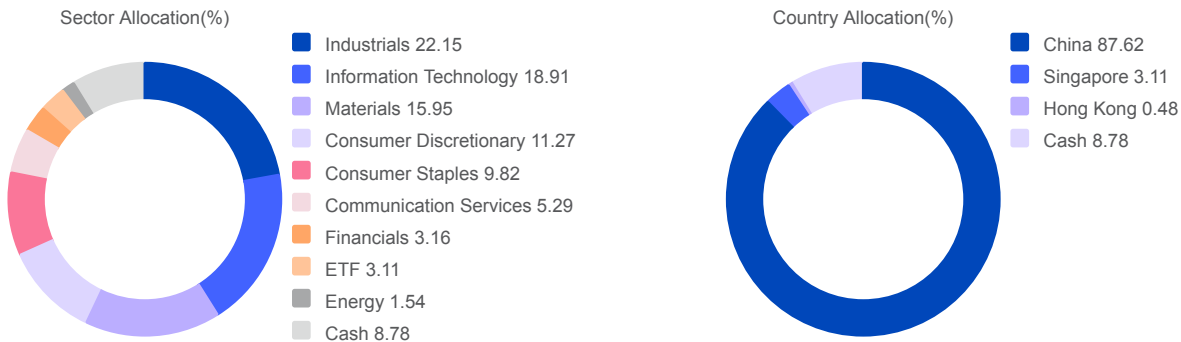
