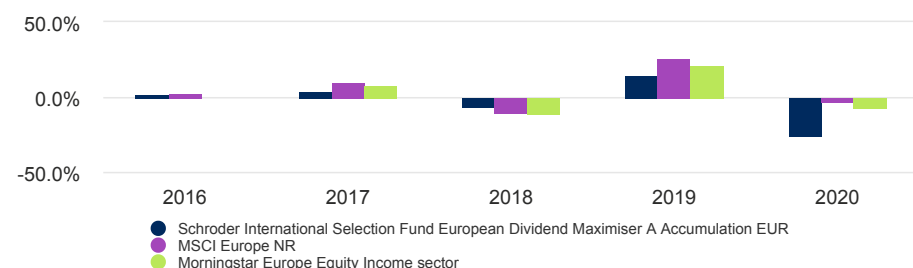

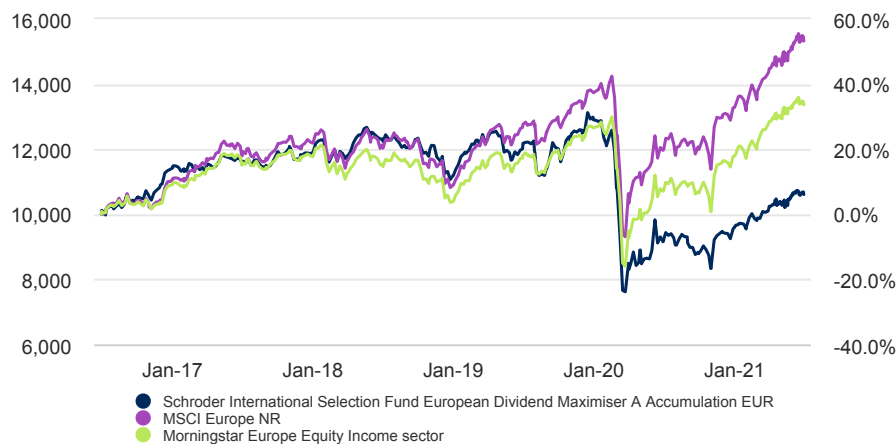

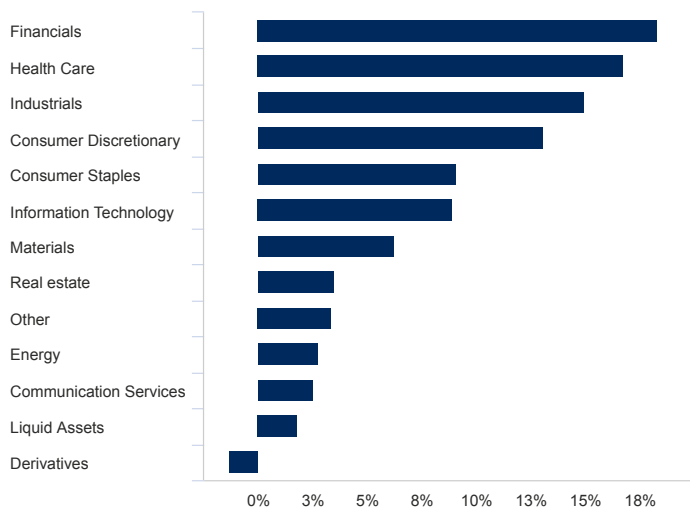

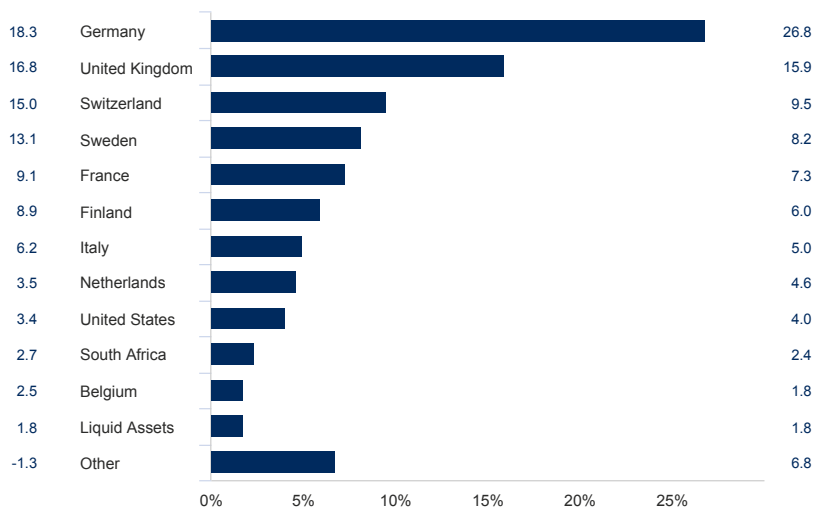

### Geographical Breakdown (%)



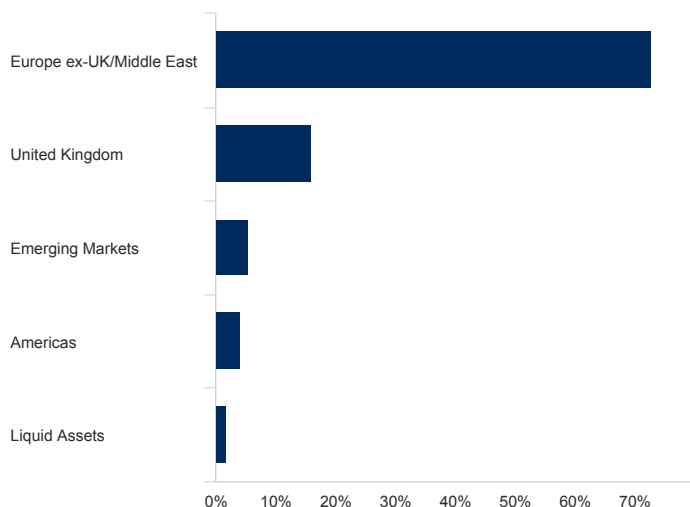
