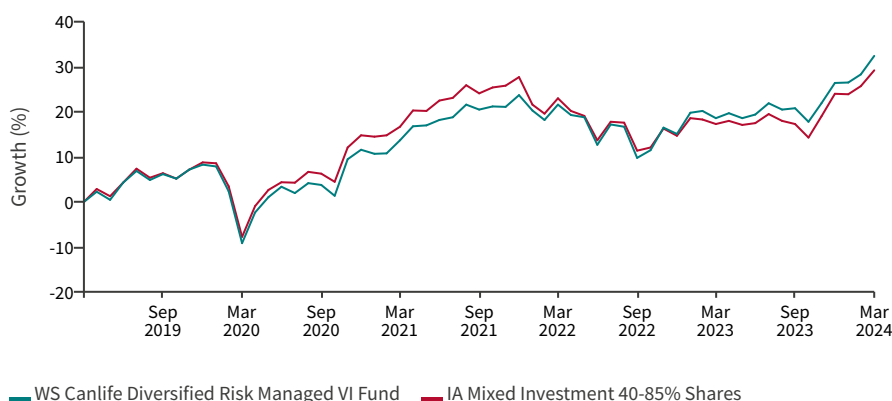


About the fund

The Fund aims to achieve capital growth over any five-year period, after all costs and charges have been taken, while seeking to remain within risk profile 6.
